VI	Treasurer Report
i. Account summary	 i. We have approx. \$150K in the checking account and \$60K in savings. We have made some large payments including senior lights, LL charter fees as well as candy. In addition, Bea Villareal hasn't deposited any sponsor checks. ii. We are at 39% of our budget and 32% of our expense. iii. We owe \$26,470 for Dad's club fees which needs to be paid. We are responsible for the Dad's Club gun raffle tickets for \$2,500.

i. Lawn treatments ii. Mound rebuilding iii. Batting cage lights iv. Workdays v. Concessions	 i. Danny Rhodes made a motion for fertilizer and ant killer for \$6,700 for the entire season. Seconded by Terry Shaffer. Motion passed. ii. The Major field mound was redone by the Astros. It looks great. They are willing to rebuild the other mounds for \$200 a per field. \$1K for the other 5 mounds. We would need 3 pallets of the packing clay which would be \$1,455. They would put condition on top. We rented a packer for \$55 a day or \$185 per week. Motion to rebuild the mounds for \$2500 by Terry Shaffer; seconded by Stephani. iii. We need \$500 for materials to build the lights in the back batting cages with a shield with a light into field 8. \$500 for the electrical services with the light packs. \$1500 total. Motion made by Terry Shaffer, seconded by Sarah Love. Motion passed. iv. Wilcox Electric provided the light bulbs for the Senior field but we can't see them at night. McRay will reimburse us for the blubs if we buy and install them. v. Work day is this Saturday. vi. We have a shortage of concession supplies for everything because of the weather issues. Shu-Kei has employees lined up for the season. We will have no food in the back because we cannot social distance. There is a soft spot in the back concession we need to keep an eye on it. He has increased the prices. vii. The plan is to order from Chick Fil A. The games schedule is going to determine which days we are going to have it.
